Liability Release / Permission Agreement

I, the applicant confirm that I am age 18 or older and release The Bridge, First Baptist Church of Peachtree City, its authorized representatives and staff from all liability of any kind and character upon any claim, demand, or cause of action which might be asserted against The Bridge, said church, volunteers, representatives, or staff.

I, the parent or legal guardian of the applicant, confirm that I am the parent or guardian of applicant and give permission for the applicant's participation in programs of The Bridge, and release The Bridge, First Baptist Church of Peachtree City its authorized representatives and staff from all liability of any kind and character upon any claim, demand, or cause of action which might be asserted in behalf of said minor against The Bridge, said church, volunteers, representatives, or staff.

Furthermore, in the event of an accident, if the said staff or representatives are unable to contact the emergency contact, parent(s) or legal guardian(s), I hereby grant permission to said staff or representatives to administer necessary first aid, and/or take applicant to the nearest medical facility for additional treatment and release The Bridge, First Baptist Church of Peachtree City, its authorized representatives and staff from all liability of any kind and character upon any claim, demand, or cause of action which might be asserted against The Bridge, said church, volunteers, representatives, or staff related to first aid treatment.

I understand that myself/my child may be video taped or photographed for promotional purposes. Also, I agree to abide by The Bridge Policies and Guidelines at all times and I understand the consequences of not abiding by these policies and guidelines.

Participant Guidelines

- 1. Children not having entered the 6th grade must be accompanied by a parent or legal guardian, 18 or older, at all times unless participating in a "staffed" program.
- 2. Students having entered the 6th grade and not yet age 18 or older who wish to use The BRIDGE facilities without a parent or legal guardian present must be have an active Bridge membership or have a visitor waiver signed by a parent or legal guardian.
- 3. Participants MUST check-in at the Front Desk before participating in any activity.
- 4. No loitering outside of The BRIDGE or in automobiles.
- 5. The BRIDGE is a no smoking facility. Smoking is not allowed anywhere on BRIDGE property.
- 6. Appropriate language must be used at all times. No profanity is allowed!
- 7. Shirts and shoes, along with modest, appropriate apparel must be worn at all times. No bare midriffs, low-cut tops, short shorts, or gang-related clothing will be allowed: shorts and pants must be worn at the waist. All underwear must be covered.
- 8. No gambling will be allowed on The BRIDGE property.
- 9. No pets are allowed on The BRIDGE property.
- 10. The following items are NOT ALLOWED on the property of The BRIDGE. If such items are found the appropriate authorities will be contacted.
 - Tobacco in any form;
 - Anything considered a weapon;
 - Any alcoholic beverage;
 - Any controlled substances or drugs;
 - Outside equipment for use in The BRIDGE (unless approved by the Bridge Director);
 - Personal items such as boom boxes, basketballs, electrical devices, video games (with the exception of cell phones and iPods), etc.;
 - Fireworks of any kind.
- 11. Any member of The BRIDGE staff has the right to eject players from gym for displaying poor sportsmanship. The length of dismissal will be determined by the Director of the Bridge.
- 12. Absolutely NO DUNKING or HANGING ON THE RIM. Violators are responsible for any damage they cause to equipment and subject to suspension of playing privileges.

Any situation not specifically covered in this list of rules will be acted upon when the need arises at the discretion of the Director of The Bridge and/or Bridge Crew Chief.
